## REQUIRED DOCUMENTS FOR REGISTRATION



- 1) The documents listed below are requested for the final registration:
- a) The original high school diploma,
- b) Diploma equivalency document (taken from Provincial Directorate of Ministry of National Education or Turkish Embassy/Consulate),
- c) Notarized copy or photocopy of the passport (if the photocopy of the passport is brought with the original copy of the passport, it can be approved by the relevant unit),
- ç) Notarized copy or photocopy of the Student Visa taken from the Turkish Embassy/Consulate (if the photocopy of the Student Visa is brought with the original copy of the Visa, it can be approved by the relevant unit),
- d) Residence Permit Certificate taken from the Migration Office,
- e) Turkish ID Number Decleration of Turkish Citizens or photocopy of the ID card of the candidates,
- f) Military Service Status of male Turkish Citizen candidates,
- g) The ones holding Dual Nationality (Being a foreign by birth then becoming a Turkish Citizen) Certificate of Identity Register Copy,
- h) Transcript from Turkish Citizens who completed their High Schools in a foreign country-except TRNC Turkish Republic of Northern Cyprus (Including the ones who completed their High Schools at a Turkish School in a foreign country- except TRNC Turkish Republic of Northern Cyprus),
- 1) Bank receipt showing that the first installment of the tuition fee of the student who has to pay the tuition fee has been deposited,
- i) 2 photographs with dimensions of 4.5x6.0,
- j) Foreign Language Proficiency Certificate, if any,
- k) Turkish Proficiency Certificate, if any,
- l) Registered students are required to have General Health Insurance within one month from the beginning of each semester according to the article 60 of the Law No. 5510.
- 2) Due to the functioning of the institutions in our country, the candidate who can not deliver any of his/her documents within the registration period is given extra time by the Registrar's Office upon proving that he/she applied to obtain the relevant document and registration is cancelled if the candidate fails to deliver the document.

#### **IMPORTANT NOTES**



- 1) Those who apply with any missing document and do not register within the registration period will lose their right to register.
- 2) Registrations are to be made by the candidate <u>him/herself or by his / her proxy</u>, who is authorized by the notary public.
- 3) Turkish level of the registered students who did not prove their Turkish proficiency (Those who do not have a TÖMER Certificate) will be evaluated by the outcome of Turkish proficiency exam result held by Language Teaching Research and Application Center in School of Foreign Languages building in 20<sup>th</sup> of September 2021 at 13:00 or by the exam applied by TÖMER. To be counted successful in the proficiency exam, at least 60 points out of 100 must be obtained. (Turkish proficiency certificate will not be required from those who completed high school education in our country).
- **4)** Students registered in Ziya Gökalp Educational Faculty Department of Foreign Languages-English and German Language Teaching- and Faculty of Theology must take Compulsory Foreign Language Preparatory Class Proficiency Exam in 21<sup>th</sup> of September 2021 at 13:00 and score at least 70 points out of 100. Candidates who cannot score 70 or above will attend a one-year foreign language preparatory class in an institution or organization.
- **5**) Students who have the right to register but fail to submit a Turkish Proficiency Certificate or fail the TYS exam conducted by the Language Teaching Research and Application Center are <u>required to attend A1 A2 Turkish courses</u> in the year in which they will be considered on leave if the Language Teaching Research and Application Center is opened.
- **6**) Registration of candidates will be cancelled and necessary judicial and administrative procedures will be made to the ones who gain advantage by making a false statement.
