IMPORTANT NOTE-1: You can learn your application result via international.dicle.edu.tr using your e-mail and access code. **PLEASE SAVE YOUR ACCESS CODE** and **APPLICATION FORM** at the end of the online application.

IMPORTANT NOTE-2: The ammont of tuition fee may increase if the Decision on the Determination of the Tuition Fees and Contributions to be Taken as Student Contribution to the Current Service Costs in Higher Education Institutions is published on the registration dates or after the registration.

IMPORTANT NOTE-3: Dicle University does not have an agreement with any person, institution or organization (education institution, consulting firm etc.). No fee is required from any candidate other than the tuition fee payment to be made to the official account of our university at the time of preliminary enrollment and online application therefore do not pay any fees to anyone.

APPLICATION REQUIREMENTS



a) The candidates stated below may apply for international students quotas, on the condition that they are in their last year of secondary education or a graduate:

- 1) Foreign nationals,
- 2) Those who are Turkish citizens by birth and have a permission from the Ministry of Interior for the renunciation of Turkish citizenship and their under age children listed in the citizenship renunciation certificate and document their certification in terms of using the given rights in accordance with Turkish Citizenship Act,
- 3) Those who are foreign nationals by birth but have a dual citizenship by obtaining a TR citizenship afterwards,
- 4) The students who have Turkish citizenship and continued their secondary education in another country prior to 01/02/2013 and completed their last three years of secondary education in another country, excluding TRNC, (Including those who completed their whole secondary education in a Turkish school opened by Ministry of National Education in another country, excluding TRNC),
- 5) Those who began secondary education in another country after 01/02/2013 and completed all of their secondary education in another country, excluding TRNC, (including those who completed all of their secondary education in a Turkish school opened by Ministry of National Education in another country, excluding TRNC),
- 6) Those who have a TRNC citizenship and reside in TRNC and completed their secondary education in TRNC and have GCE A/L exam scores,
- 7) Those who enrolled to private or regular high schools and received education from those schools in other countries between 2005-2010 years and hold, or are to hold, GCE A/L exam scores,

b) The applications of those stated below will not be accepted:

- 1) Those who are Turkish citizens and completed their whole secondary education process in Turkey or TRNC,
- 2) TRNC citizens (excluding those who completed secondary education in TRNC and who enrolled private or regular high schools and received education from those schools in other countries between 2005-2010 years and hold, or are to hold, GCE A/L exam scores),
- 3) Dual nationals by birth specified in the 2nd sub-clause of sub-article a (excluding those who provide the conditions explained in the 4th and 5th sub-clause of the sub-article a).
- 4) Dual nationals with TRNC citizenship (excluding those who completed their secondary education in TRNC and have GCE A/L scores or who enrolled and attended private or regular high schools in other countries between 2005-2010 and hold or are to hold GCE A/L scores),
- 5) Dual nationals who have Turkish citizenship or have Turkish citizenship by birth specified in the 2nd sub-clause of the sub-article 'a' and who attended schools within embassies in Turkey or foreign high schools in Turkey,
- 6) Those who have been involved in an activity against Turkish Republic or who were deprived of Turkish citizenship as a sanction,

PROGRAM SELECTION CONDITIONS

ACCEPTED INTERNATIONAL TESTS AND BASE SCORES

1. The students are accepted to the quotas of international students in Medicine, Dentistry, Pharmacy and Law programmes by considering only YÖS (International Student Examination) implemented by universities in Turkey, High School Graduation Examinations or International University Entrance Exams. Apart from above mentioned programmes, students are accepted to quotas of international students by YÖS (International Student Examination) implemented by universities in Turkey, High School Graduation Examinations, International University Entrance Exams or Grade Point Average of Secondary Education. Score type(s) that will be used for the placement and the dispersion of scores in accordance with the quotas are determined by the decision of the Commission. Minimum criteria for scores and score types that will be stated in online application are given below:

a) Candidates must have 40 standard points or over obtained from the Basic Learning Skills Test of YÖS (International Student Examination) implemented by universities in Turkey,

b) Candidates must have 40 standard points or over out of 100 obtained from National University Entrance Exams implemented in students' own countries,

c) Candidates must have 60 standard point or over out of 100 in terms of high school diploma score.

2) Only one YÖS score type (that is indicated during application) of those who have more than one score type is evaluated.

3) The scores of the students, who have international diplomas with different score types, are evaluated by converting the scores into 100-point grading system by means of Grade Conversion Table prepared by the Council of Higher Education.

4) For the candidates who will apply, there is no limitation in terms of the validity duration of the High School Graduation Examinations (Abitur, International Baccalaureate, GCE, Tawjihi etc.) approved by the Council of Higher Education.

5) The validity duration of examinations stated among the University Entrance Exams (SAT, Gaoka...etc.) is two years.

6) The validity duration of results obtained from YÖS (International Student Examination) implemented by universities in Turkey is two years.

7) According to decisions of the Council of Higher Education conducted on 04.07.2019 and 30.03.2021, in accordance with the Principles of Accepting International Students, it was decided not to exceed 10% of the quotas determined for those who have right to apply the quotas for international students, the candidates who have blue card, TR citizens who completed high school abroad (excluding TRNC) and dual nationals who have Turkish citizenship (pertaining to Teaching, Law, Medicine, Dentistry and Pharmacy programs stated in the international student quotas specified by the Council of Higher Education)



REQUIRED DOCUMENTS FOR APPLICATION

(THE DOCUMENTS THAT NEED TO BE UPLOADED DURING ONLINE APPLICATION)

- 1) Copy of high school diploma in Turkish approved by the public notary or the Turkish Embassy / Consulate: "Equivalence Document", which proves that candidates' high school diplomas are equivalent to diplomas taken from Turkish high schools and which can be obtained from the Ministry of National Education or the Turkish Embassy / Consulate in candidates' own countries, will be required during the enrollment for those who have not received a formal Equivalent Certificate).
- 2) Transcript: If the transcript is not in Turkish, a copy translated into Turkish and approved by the public notary or the Turkish Embassy / Consulate must be submitted.
- 3) The exam result of YÖS (International Student Examination) implemented by the state or private universities in Turkey (Original or internet output).
- 4) Copy of passport translated into Turkish and approved by the public notary or the Turkish Embassy / Consulate.
- 5) All of the documents uploaded to online application page need to be original or approved copy. The copied documents without an original stamp or signature will not be accepted. The applications with missing document will not be evaluated.
- 6) Turkish Citizens, who graduated from the secondary education institutions opened in the presence of Ministry of National Education in other countries or from secondary education institutions in another country that are equivalent to the ones in Turkey, are required to certify this by obtaining a document from the Turkish Embassy/Consulate or TR Directorates of National Education.

PROGRAM SELECTION

- 1) Applications are made between the dates announced on Dicle University's official website as determined.
- 2) The candidates who provide the application requirements can select programs.
- 3) The candidates can choose at most 3 (three) diploma programs.

THE EVALUATION OF THE APPLICATIONS



1) Considering the order of selections, the candidates are placed in only one program in accordance with the quotas by sequencing candidates' scores from the highest to the lowest. The score type(s) that will be used for the placement of the candidates and the dispersion of score types according to the quotas are determined with the decision of the Commission.

2) The applications of the candidates which do not provide the required conditions are not evaluated.

3) For the programs that accept students with special talent test, the applications are evaluated by considering 50% of application exam score and 50% of special talent test score.

4) The evaluation of the applications made to the quotas and the placement of the candidates are completely under the authority of Dicle University. It is under the discretion of Dicle University to fill available quotas. To fulfill the eligibility criteria does not guarantee admission.

TURKISH PROFICIENCY



1) The language of education is Turkish at Dicle University.

2) To start education in a Turkish-medium education program after the registration:

a) The students that are found to be incompetent in Turkish are required to get **60 out of 100** from the Turkish Proficiency Exam (TYS) that will be implemented at the second week of the education process in accordance with the 3rd sub-article of 16th article of Dicle University Language Teaching Application and Research Center's regulation.

The candidates stated below are not required to provide a new Turkish Proficiency Certificate:

b) Those who have a Turkish Proficiency Certificate given by Dicle University or another Higher Education Institution in Turkey,

c) Those who have a Turkish Proficiency Certificate given by Yunus Emre Institute,

ç) Those who completed their secondary education in Turkey's high schools which are in the presence Ministry of National Education.

3) Turkish Proficiency Levels explained in accordance with European Language Portfolio are stated below:

C2 Level: Proficient in Turkish and can start education.

C1 Level: Proficient in Turkish and can start education.

B2 Level: Turkish proficiency can be improved in a short time, can still start education, but it is necessary to reach C1 or C2 level in terms of Turkish proficiency prior to graduation.

B1 Level: Turkish proficiency level is adequate to start education at Dicle University but it is necessary to reach C1 or C2 level in terms of Turkish proficiency prior to graduation.

A2 Level: Not adequately proficient in Turkish, it is required to learn Turkish in one-year duration during when they are granted a leave of absence. After having B1 level, they can start education, but it is required to reach C1 or C2 level in terms of Turkish proficiency prior to graduation.

A1 Level: Not adequately proficient in Turkish, it is required to learn Turkish in one-year duration during when they are granted a leave of absence. After having B1 level, they can start education, but it is required to reach C1 or C2 level in terms of Turkish proficiency prior to graduation.

4) Those who gain right for registration but cannot submit a Turkish Proficiency Certificate or fail in TYS (Turkish Proficiency Exam) implemented by Language Teaching Application and Research Center are required to attend A1-A2 Turkish courses for one year when they will be granted a leave of absence on the condition that Dicle University Language Teaching Application and Research Center is opened.

PROFICIENCY IN FOREIGN LANGUAGE



1) During the registration, the candidates accepted for the programs that have compulsory preparatory foreign language education or give education in a specific foreign language are required to submit the result of International Foreign Language Tests that shows an obtained adequate score accepted by Interuniversity Board. Those who cannot submit such a document are required to take Foreign Language Proficiency Test implemented by Dicle University, School of Foreign Languages and have at least 70 out of 100.

2) If the candidates fail Foreign Language Proficiency Test, they can continue preparatory foreign language education either at Dicle University, School of Foreign Languages or in another foreign language teaching center.

3) The registration of those who are not able to reach required foreign language level in two years is deleted.

THE ANNOUNCEMENT OF THE RESULTS



- 1) Placement results are announced on Dicle University's webpage.
- 2) The registration procedures of those who gain an exact registration right are done by the candidate or Registrar's Office with a notary attorney.
- 3) For the candidates granted registration right, a 'Letter of Acceptance' is prepared. This document can be used to receive a 'Student Visa'. The candidates are required to have a Student Visa from Turkish Representative Offices stated in their country (or from the nearest one) by applying with the Letter of Acceptance.
- 4) The candidates who are in Turkey need to get a Residence Permit from the Ministry of Interior, General Directorate of Migration Management.
- 5) Tuition fees are received with two equal installments over the rates determined by Dicle University, Board of Management.
